Hetzner renuncia a bloquear Kaosenlared y retira la exigencia de borrar artículos

El lunes 5 de noviembre, a las 11:00 hs. (GMT+1) terminaba el plazo que Hetzner había dado para el borrado de 8 artículos en Kaosenlared bajo amenaza de bloquear su servidor. En [este artículo](#) informamos de este hecho. Después de que se hubiera sobrepasado en una hora el plazo sin que se produjera ningún bloqueo, recibimos un mensaje de Hetzner en el que nos comunicaban que desestimaban la queja contra Kaosenlared y que no se iba a producir ningún bloqueo. Consideramos esto como una importante victoria.

Como ha sido habitual, los mensajes de Hetzner son lacónicos y no dan muchas explicaciones:

After the expiry of the deadline, our manual check has resulted in our decision to close this ticket.
We are not going to block your IP.
This ticket has now been closed.

Traducción: *Después de acabado el plazo, tras una revisión manual, hemos decidido cerrar este caso. No vamos a bloquear su IP. Este ticket ha sido cerrado.*

Pero no tenemos ninguna duda de que ha sido determinante la campaña de denuncia de este intento de censura y la enorme solidaridad recibida, que agradecemos profundamente.

Por supuesto los planes para mover nuestra plataforma de servidores dedicados a un centro de datos mas seguro siguen en marcha.

Además nos consta que el anónimo censor sionista sigue insistiendo con Hetzner, hoy mismo ha abierto otra queja en los siguientes términos:

If you suspend the server due a very clear breach of your terms, you don't lose a client [the client is lost], these groups are moving their servers to countries and providers that speculate about freedom of speech.

The breach is clear, suspend the service.
Don't underestimate me and my commitment, I have links with the Central Council of Jews in Germany, give me a definitive reply, I don't want to act without your definitive reply.

Traducción: *¡Si suspenden el servidor debido a un incumplimiento claro de sus términos de contratación, ustedes no pierden un cliente (el cliente ya está perdido), estos grupos están moviendo sus servidores a países y proveedores que especulan con la libertad de expresión. La violación del contrato es clara, suspenda el servicio. No me subestime a mí y a mi compromiso, tengo vínculos con el Consejo Central de los Judíos en Alemania, deme una respuesta definitiva, yo no quiero actuar sin su respuesta definitiva.*

I work in an anti-fraud and security company, and I'm a member of the AFI-CAT (Catalan Association of Friends of Israel).

Well, we have been made aware that a domain name, operated by ultra-anti-system group, that redirect traffic to a website that promotes net abuse and contains derogatory, hateful, defamatory and bigoted content against Israel (democratic country), Israel people and the Jews has been registered with you.

In Canada, inciting hatred against any 'identifiable group' is an indictable offence under the Criminal Code. An identifiable group is defined as any section of the public distinguished by colour, race, religion, ethnic origin or sexual orientation.

CRIMINAL CODE

319.(2) "Everyone who, by communicating statements, other than in private conversation, wilfully promotes hatred against any identifiable group is guilty of..."

298.(1) A defamatory libel is matter published, without lawful justification or excuse, that is likely to injure the reputation of any person by exposing him to hatred, contempt or ridicule, or that is designed to insult the person of or concerning whom it is published.

Please suspend the domain due a breach in your Terms of service:

The Applicant agrees not to use the services provided by easyDNS to conduct any business or activity or solicit the performance of any activity that is prohibited by law.

easyDNS reserves the right to revoke without refund or notice: DNS, nameserver delegations, email forwarding and web forwarding service from any domain name that, in easyDNS' judgement, has been used or is likely to be used for the following activities (but not limited to):

- unlawful or illegal activities of any kind (this includes ponzi schemes and HYIPs)
- promotes net abuse in any manner (providing software, tools or information which enables net abuse)
- Such determination on what constitutes a violation of the above or whether a domain has or is "likely" to violate the above is solely at the discretion of easyDNS.

Please suspend the service due a breach in your Terms of service:

6.2 The client undertakes not to publish content that may violate the rights of third parties or otherwise violate the law. The placement of erotic, pornographic, extremist material or material not deemed in good taste is not permitted. We are entitled to block access to the account of any customer who violates this.

The same applies in the event that the customer publishes content which is capable of violating the rights of individuals or groups of people, or that insults or denigrates these people. This applies even without an actual legal claim. We are not obligated to review our customers' content.
